of an NRA affiliated club. NORTH DAKOTA RESIDENTS are encouraged to be members of the NORTH DAKOTA SHOOTING SPORTS ASSOCIATION. State Association

Memberships will be available at the match.

**RULES** : Current NRA international Air Rifle Rules will be used.

**DISTANCE** : 10 meters (33 feet)

**RIFLE** : Rule 3.6, Air Rifle

SIGHTS : NRA Rule 3.7(a), Metallic only

**TARGETS** : AR-5/10 (10 Bulls eye) Air Rifle Target

CLASSIFICATION: The NRA Classification System will be used. Unclassified Competitors will fire in the Master Class.

Scores from a Temporary Score Record Book to establish a classification is Acceptable

**CHALLENGES**: The challenge fee will be \$1.00 per bulls eye. See NRA Rule 16.1 for correct procedure

**ENTRIES**: Entries should be made at least 7 days preceding the firing date. Late entries may be accepted to the

range capacity. Mail your Entry with the correct fees to Rick Jorgenson at the above Address Checks should be made payable to Rick Jorgenson. Entries are limited to 28 competitors.

MATCH FEES : Juniors -\$11per individual, Team entry fee is \$12 per team

**TIME LIMITS**: 80 minutes total firing time (2 minutes/record shot), additional Time will be allowed

for target changes

**RELAY TIMES**: ALL TIMES ARE CENTRAL TIME - 13 firing points for each relay

Saturday & Sunday - 9:00am, 11:00am, \*1:00 pm (only if necessary) each day

\*We will squad the 1:00pm relay only if the early relays are

completely filled

COURSE OF FIRE: 40 shots standing, one shot per bullseye - unlimited sighting shots may be taken within the time limits

before going for record on any target card. See Rule 9.2

**TEAM MATCH:** Open to teams consisting of three (3) firing members and a designated Team Captain who may also be a

firing member of the team. The team must represent a single NRA Affiliate Club. The team match is not a

fired match.

**AWARDS** : Awards will be provided by the sponsors and the National Rifle Association. At a minimum, awards

will be given for Match Winner & 1st place in each class. Separate class awards will be given provided

there are 3 or more competitors per class.
